Bottom-up security selection that establishes an all-cap diversified long portfolio primarily targeting developed-market company stocks possessing attractive valuations, strong fundamentals, and positive business momentum, as well as a diversified short portfolio of companies that do not possess these characteristics.

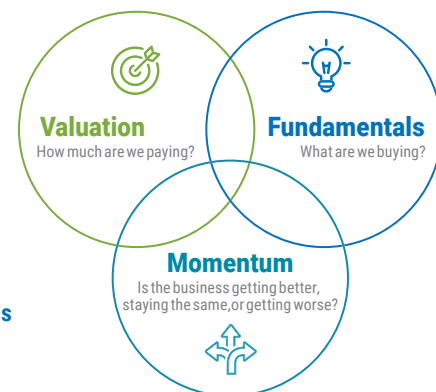

GLOBAL L/S STRATEGY UCITS | Q1 2026

After a solid start to the year, global stock markets sold off in March amid U.S. and Israeli military operations in Iran, which sent oil prices up by more than 50% to finish the quarter at over \$100 per barrel. The decline was enough to push certain segments of the equity market—and in many cases, the market as a whole—into negative territory for the quarter, the first quarterly loss since Q1 2025. Although the downturn in March was broad based, performance in Q1 was more mixed, and many value-oriented indexes finished the period in positive territory. It was notable that value stocks continued to outperform their growth counterparts in each of the first three months of the year and for the quarter as a whole, suggesting that the highly concentrated collection of artificial intelligence (AI)-related stocks that dominated market performance in 2025 may not be as much of a factor as the new year continues to unfold. The U.S. dollar, also in a reversal from last year, was up moderately for the quarter, which acted as a modest headwind for domestic investors with holdings denominated in foreign currencies.

The Boston Partners Global Long/Short UCITS fund posted a gain of 6.49% for the quarter and outperformed its benchmark, the MSCI World Index Net which has declined -3.57%. Long positioning within the Information Technology and Materials sectors contributed positively to relative returns, as did the strategy's short positions overall. Long holdings in Health Care and Consumer Discretionary acted as the biggest drag on relative results.

Standout contributors for the quarter included a long position in Samsung Electronics. Samsung's memory semiconductor segment has seen significant earnings growth, as chip prices have risen significantly due to the AI infrastructure boom; additionally, the company has begun mass production and commercial shipments of high-bandwidth memory chips. Elsewhere, Italian oil services company Saipem benefited from the jump in Brent crude from around \$60-\$70 to above \$100 per barrel. The company announced new offshore contracts in the Middle East, contributing to a near-record-high backlog. Our long exposure boosted returns.

Notable detractors included a long position in Indian financial services company HDFC Bank. The military conflict in Iran and subsequent rise in oil prices have been particularly challenging for the Indian economy given its position as a significant net importer of oil. Another detractor was our long position in Sony. Shares sold off, along with a number of Asian Consumer Discretionary names, amid March's geopolitical turmoil and more acute concerns that Sony's gaming profits could be undermined by rising memory costs.

The fund's largest net overweight exposures at the end of the period included Materials and Energy, where we added several new long positions in the former, including Methanex Corporation and Tungsten West, and Galp Energia and Shell in the latter. Information Technology was the largest net underweight, and we initiated several new short positions, including in Sandisk and Wipro Limited.

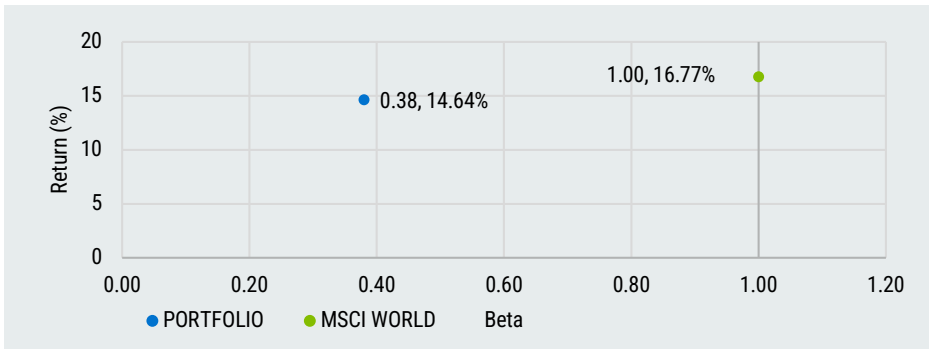

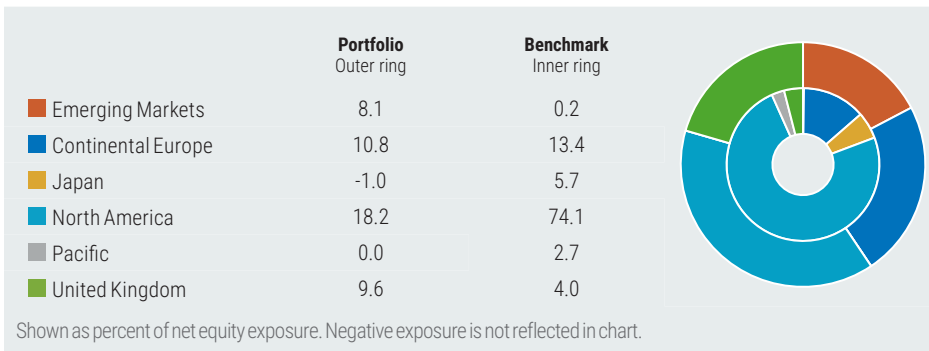

Investment Terms:

Alpha: A measure of performance on a risk-adjusted basis. Alpha takes the volatility (price risk) of a product and compares its risk-adjusted performance to a benchmark index. The excess return of the product relative to the return of the benchmark index is the alpha. **Price-to-Book (P/B):** The price per share of a stock divided by its book value (net worth) per share. For a portfolio, the ratio is the weighted average price-to-book ratio of the stocks that it holds. **Price/Earnings Ratio:** A method of valuing stocks, calculated by dividing the closing price of a company's stock by its annual earnings per share. A higher multiple means investors have higher expectations for future growth and have bid up the stock's price. P/E FY1 is simple measure of one-year earnings per share growth from the prior fiscal year (FY0) to the current fiscal year. **Return on Equity:** A measure of a corporation's profitability that reveals how much profit a company generates with the money shareholders have invested.
