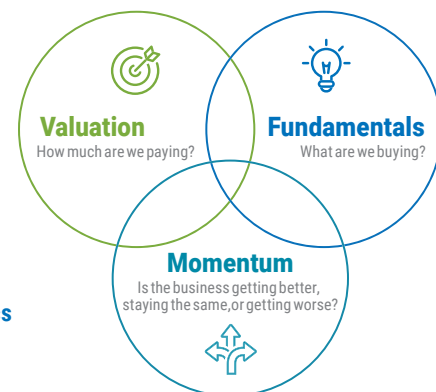

GLOBAL L/S STRATEGY UCITS | Q2 2026

The Boston Partners Global Long/Short UCITS Fund trailed the MSCI World index during second quarter with the fund rising 3.32%, compared to a larger increase of 13.75% for the index. The short portfolio was the primary detractor from relative returns during the quarter, while the long portfolio contributed on an absolute basis. Fund short positions climbed higher by nearly 13% during the quarter, with Information Technology, Financials, Industrials and Consumer Discretionary weighing on performance during the period. In Information Technology, first quarter earnings led to a strong second quarter, performance-wise, with fund short positions moving higher, outpacing MSCI World tech constituents. The same is true in Financials, where fund short positions moved higher by nearly 10%, while in Consumer Discretionary and Industrials, shorts moved higher by just under 12% and 8%, respectively. Within the long portfolio, fund holdings partially offset disadvantages in the short portfolio, with strong contributions coming in Information Technology, Financials and Health Care. In Information Technology, where fund holdings soared higher by 83%, top contributors came in Marvell Technology, Kioxia Holdings, Samsung Electronics, Murata Manufacturing and Renesas, all of which climbed significantly higher, ranging from 97% to 360% during the quarter. In Financials, ABN AMRO, Samsung Fire and Marine Insurance, Admiral Group, and Danske Bank all climbed higher by 13% or more. Materials was the only sector to detract meaningfully during the quarter.

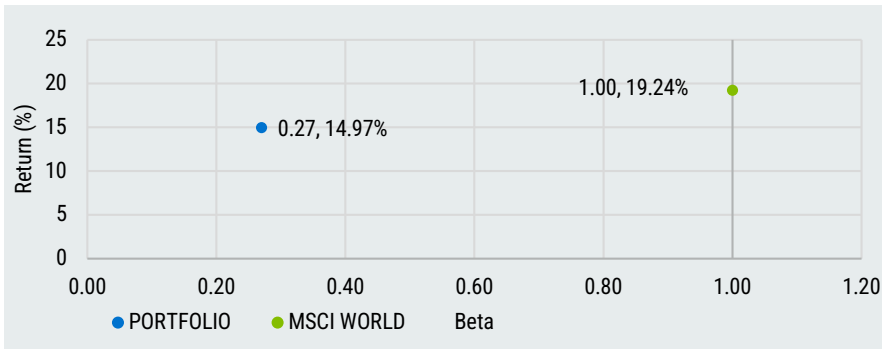

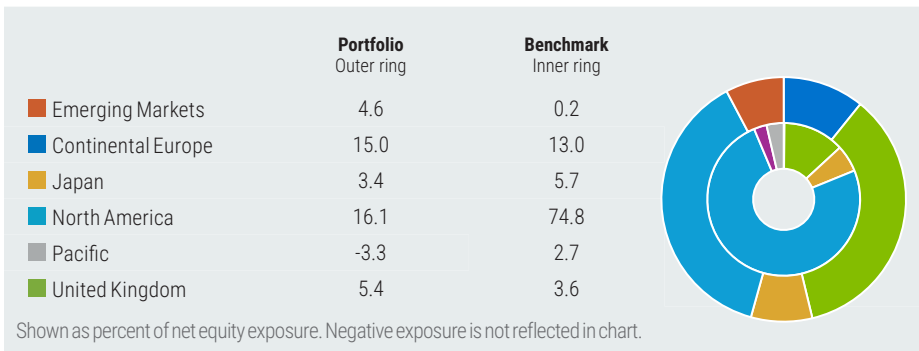

Investment Terms:

Alpha: A measure of performance on a risk-adjusted basis. Alpha takes the volatility (price risk) of a product and compares its risk-adjusted performance to a benchmark index. The excess return of the product relative to the return of the benchmark index is the alpha. **Price-to-Book (P/B):** The price per share of a stock divided by its book value (net worth) per share. For a portfolio, the ratio is the weighted average price-to-book ratio of the stocks that it holds. **Price/Earnings Ratio:** A method of valuing stocks, calculated by dividing the closing price of a company's stock by its annual earnings per share. A higher multiple means investors have higher expectations for future growth and have bid up the stock's price. P/E FY1 is simple measure of one-year earnings per share growth from the prior fiscal year (FY0) to the current fiscal year. **Return on Equity:** A measure of a corporation's profitability that reveals how much profit a company generates with the money shareholders have invested.
